1514: Public Participation

The meeting was adjourned at 19:05 for a period of public participation. The Chairman welcomed to the meeting 7 members of the public and Guest Speaker, Mr Matthew Ashton, Director of Public Health Sefton.

Matthew Ashton touched on some of the biggest 21st century public health challenges, including an ageing population; the burden of unhealthy lifestyle choices; inequalities within the healthcare system; the health impacts of climate change and environmental pollution; and the potential for global pandemics. He spoke of community power, a person centred approach, that does not rely on formal health and care services, to influence local priorities, for example: monitoring emissions around local schools. Residents discussed the following issues:

- How to influence housing developers to invest in local infrastructure, including the trees, roads, access to local amenities, shops, health and schools?
- How to influence public transport to comply with 'No-Idling' outside schools?
- How to influence residents to visit pharmacists for less serious health issues?
- Has air quality improved in the designated zones in the two years since pupils took part in Sefton's community air watch diffusion tube monitoring scheme?
- How can Thornton create a monitoring zone for measuring local air pollution?
- Does the self-quarantine site at Arrowe Park Hospital increase the risk of coronavirus spreading to Sefton?

RESOLVED:

(a) That Cllr. O'Keeffe to contact Thornton headteachers to recommend that bus companies/drivers turn off their engines in a 'No Idling' initiative to improve air quality around schools.

(b) That the clerk to contact Anne-Marie Clegg, Environment Education Officer, for information on setting up an air watch diffusion tube monitoring scheme at schools in Thornton.

The meeting was reconvened at 20:15.

1515: Adoption of a Telephone Kiosk

Cllr. O'Keeffe led discussions on the proposal to adopt a decommissioned telephone kiosk for the housing of a community defibrillator on The Crescent at a cost £1.00 (inclusive of VAT).

RESOLVED:

- (a) That the Parish Council to be responsible for the appointment of an NICEIC registered electrician to check the illumination of the kiosk and the installation of the defibrillator.
- (b) That the Parish Council to be responsible for the monitoring, maintenance and repair of the defibrillator and the kiosk.
- (c) That Cllr. McGill to sign the purchase agreement agreeing to all the conditions therein and to return it to BT.com at the address supplied.
- (d) That the clerk to raise a cheque for the sum of £1.00 payable to BT.com.

With a focus on celebrating two key elements: relating the history of Brooms Wayside Cross dating back to 1300 and creating an accessible green space for the community to enjoy.
