## Minutes of an Ordinary Meeting of Council Held on Monday, 2<sup>nd</sup> March 2020 at Holy Family High School

**1524: Apologies for Absence**

**1526: Minutes of an Ordinary Meeting**

**RESOLVED:** That the minutes of an Ordinary Meeting held on Monday, 3<sup>rd</sup> February 2020, be approved and signed by the Chairman as a correct record.

**1528: Public Participation**

The meeting was adjourned at 19:05 for a period of public participation. The Chairman welcomed to the meeting 16 members of the public and two guest speakers, Mr Dave Kitchin and Mr Dave McNally, from the North West Ambulance Service.

The two Daves delivered an interesting and informative presentation on the vital work of the NWAS: covering a population of 7.5 million, across an area of 5,500 square miles, through the emergency 999 service, NHS111 and non-emergency patient transport service. Responding to 1000-1150 calls per day, with 'category 1' calls (cardiac or respiratory arrest) having an average response time of 7 minutes. Residents discussed the following:

- Number of public freely accessible defibrillators in the Thornton area
- Map/list identifying gaps in the local area not covered by AEDs
- How to access secured AEDs (key coded/locked cabinets)
- Training/experience needed to become a community first responder
- Training/experience needed to become a volunteer car driver
- Why defibrillators are not mandatory in public buildings
- Can anyone access an AED and are they user friendly
- Cardiac arrest survival rates: 9:1% without early CPR and defibrillation
- Cardiac arrest survival rates: 42.6% with early CPR and defibrillation
- They won't save everyone, but they do give everyone a fighting chance

**RESOLVED:** That Cllr. O'Keeffe to consult with Dave McNally, NWAS Community Engagement Manager, on a map/list of defibrillators in the L23 area.



The meeting was reconvened at 19:45.

**1529: Flooding on Lydiate and Runnells Lane**

Cllr. Pennington reported on land drainage/flooding issues at the site of David Wilson Homes (Barratt's) development, known as Sundial Place. Stating, "Recent heavy rain has left the building site and adjacent fields flooded with water spilling into gardens of residents on Lydiate and Runnells Lane, also flooding nearby roads. The area looks like an inland sea due to the volume of water that is held on the land."

**RESOLVED:**

- (a) That Cllr. Pennington to invite SLPC councillors and residents to an informal meeting to discuss the impact of drainage/flooding issues at Sundial Place.
- (b) That Cllr. Pennington to lodge a complaint with Sefton Planning Enforcement Officer to find a full resolution to the drainage/flooding issues at Sundial Place.

**1530: Road Traffic collisions and speeding on Moor Lane, The Crescent, Green Lane and Hartdale Road**

Cllr. Pennington led discussions on Thornton's road traffic issues, including:

- Fatality junction Moor Lane/Edge Lane; two car crash junction Green Lane/Park View; RTA involving a schoolboy junction Virgins Lane/Moor Lane
- Road closures, volume of traffic, rat-run through The Crescent and speeding
- Sefton Highways to conduct a traffic and pedestrian survey in response to the request for a pedestrian crossing to be located near St Joseph's Hospice

**RESOLVED:**

- (a) That Cllr. Pennington to press Ward Cllr. McGinnity to look into traffic issues around Edge Lane, The Crescent, Moor Lane and Green Lane area.
- (b) That Cllr. O'Keeffe to press Dr Stephen Birch for a response on the timescales of the introduction of planned changes to the Moor Lane/Edge Lane signals.

**1531: Funding Application: Brooms Wayside Cross**

Noted: Grant application for the cost of the restoration of Brooms Wayside Cross, a plaque and signage will be made to Manor Ward Councillors and not to Sefton Borough of Culture 2020 as previously reported.

**RESOLVED:**

- (a) That Cllr. Donegan to complete a Manor Ward Grant Application for the cost of restoration of Brooms Wayside Cross, a plaque and signage.
- (b) That Cllr. Donegan to continue to press Sefton Highways on the maintenance of Brooms Cross Path and clearance of Japanese Knotweed from Holgate.

**1532: Air Quality: 'No-Idling' Initiative**

Cllr. O'Keeffe reported on a positive response to the 'No-Idling' Around Schools Initiative from St William of York Catholic Primary School.

**RESOLVED:** That Cllr. O'Keeffe to pass the contact details of the schools Airwatch scheme to Mr Murphy, Headteacher of St William of York Catholic Primary School.


